Section 6 - Accidental Release Measures

Accidental release: This product is sold in small packages, and the accidental release from one of these is not usually a cause for concern. For minor spills, clean up, rinsing to sewer and put empty container in garbage. Although no special protective clothing is normally necessary because of occasional minor contact with this product, it is good practice to wear impermeable gloves when handling chemical products. Section 7 - Handling and Storage

Section 11 - Toxicological Information

Chronic Potential Health Effects: Boric acid can accumulate in the body (brain, bone) with repeated exposure. Prolonged or repeated skin contact may cause dermatitis. May cause borism characterized by dry skin, skin eruptions, and gastric disturbances.

Section 12 - Ecological Information

This product is unlikely to adversely effect the environment. Salts, acids and bases are typically diluted and neutralised when released to the environment in small quantities. Expected to not be an environmental hazard.
