Section 4 - First Aid Measures

General Information:

Skin Contact: Irritation is unlikely. However, if irritation does occur, flush with lukewarm, gently flowing water for 5 minutes or until chemical is removed.

Eye Contact: Flush the contaminated eye(s) with lukewarm, gently flowing water until the product is removed, while holding the eyelid(s) open. Take care not to rinse contaminated water into the unaffected eye or onto the face. Obtain medical attention if irritation persists.

Section 5 - Fire Fighting Measures

Potential Health Effects

Inhalation:
